"No School, other than a school established, owned or controlled by the appropriate Government or the local authority, shall, after the commencement of this Act, be established or function, without obtaining a certificate of recognition from such authority, by making an application in such form and manner, as may be

3. In the reference cited 3<sup>rd</sup>, the Government issued G.O vide G.O.(MS)No.144, School Education prescribed." (GE) Department dated 18.09.2014 making it mandatory for Schools affiliated to boards other than Secondary / Higher Secondary Boards of the State Government to get necessary recognition from the Director of School Education.

With reference to the application received from the School Management and school Inspection duly caused on 22.08 2022 and with reference to the G.O.8th read above and Proceedings of Commissioner of School Education 9th read above renewal of Recognition is hereby accorded to CARE INTERNATIONAL SCHOOL, NO.27, THAYANUR DINDIGUL MAIN ROAD, TIRUCHIRAPPALLI - 620 009 (Survey No.S.F.No. 9/10.9/6.9/9.9/8.8/2A1G.8/2A1H) for Classes LKG to XIIth Std for the period from 26.06.2022 to 31.05.2023.

The above recognition is subject to the following conditions:-

- The temporary recognition accorded to the school is valid up to 31.05.2023 and is to be renewed at an interval of every three years.
- The School shall abide by the provisions of the Right of Children to Free and Compulsory (2)Education Act, 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.
- The School shall admit in pre-school / class I to the extent of 25% of the strength in each class, (3) children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
- The School shall maintain a separate bank account for the purpose of reimbursement. (4)
- The School shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
- The School shall not deny admission to any child, -(6)
  - (a) For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
  - (b) On the ground of religion, caste or race, place of birth or any of them.
- (7)The School shall ensure that,-
- (i) No child admitted shall be held back in any class or expelled from School till the completion of elementary education in a school;
- No child shall be subjected to physical punishment or mental harassment. (ii)
- No child is required to pass any board examination till the completion of elementary education; (iii)
- Every child completing elementary education shall be awarded a certificate as laid down under (iv) rule 21.
- Inclusion of students with disabilities / special needs as per provision of the Act. (v)
- The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act: (vi) Provided that the teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
- The teacher performs his duties specified under sub-section (1) of section 24 of the Act; and (vii)
- The teacher shall not engage himself for private teaching activities. (viii)
- The School shall follow the basic requirements and syllabus on the basis of curriculum laid (xi) down by Appropriate authority.
- The School shall maintain the standards and norms as specified in section 19 of the Act (x)
- No unrecognized classes shall run within the premises of the school or outside in the name of (xi)
- The School building or other structures and the grounds are used only for the purposes of (xii) education and skill development.

- (xiii) The School is run by a society registered under the Tamil Nadu Societies Registration Act, 1975 (Tamil Nadu Act 27 of 1975), or a public trust—constituted under any law for the time being in force;
- (xiv) The School is not run for profit to any individual, group or association of individuals or any other persons;
- (xv) The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared. A copy each of the Statements of Accounts should be sent every year to the competent Authority granting recognition.
- (xvi) The recognition Code Number shall be quoted for any correspondence with the competent authority.
- (xvii) The School shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the School;

## C.(1) The School Management shall ensure renewal of the following Certificates as per the due Dates.

- License permitting the use of the School building as Public Building under The Tamil Nadu Buildings (Licensing) Act, 1965 (Tamil Nadu Act XIII of 1965);
- (ii) Structural Stability Certificate for the school building issued by the Executive Engineers of the Public Works Department or from the Chartered Engineers in the panel of qualified and Registered Engineers maintained by the District Collectors in accordance with the Tamil Nadu Public Buildings (Licensing) Act, 1965;
- (iii) Sanitary and Hygiene Certificate issued by the Health Officer of the locality and;

- School management should not be issuing transfer certificate forcefully to any student on account of student's academic performance and should not indulge in compelling the student to take the board 15. examination as a private candidate.
- School management should not be withholding transfer certificate in terminal classes or in any other classes for non-payment of fees as it might cause irreparable damage and severely harm the higher 16. education prospects of the child and pendency of fee payment can be separately tracked with the parent concerned. The School management should take in to cognizance the direction given by The Hon'ble Madurai Bench of Madras High court in its judgment in W.P.No.9242/2017 & 9243/2017 dated: 18.05.2017 wherein it has been categorically stated that "No school has any authority to deny the issuance of the transfer certificates and other documents... A report should be submitted periodically to this office about the process and progress of the plan approval by DTCP and at all cost should be having DTCP Approval for the school buildings within the stipulated time frame as it has been categorically mentioned in the G.O.No.221 (1D) School Education Department (MS) Dated. 10.08.2022 that any further extension of time would be given in this regard any more.
  - 11 S.F.No.s mentioned for regulation of school's site plan and buildings under sec 113-C of Town & Country Planning Act, 1971are mentioned as S.F.No. 8/2A1G, 8/2A1H, 9/8, 9/9 & 9/10 and in the certificate of land issued by the District Revenue Officer as attached by the school Management said to be for school purpose S.F.No.s 9/6, 9/7 & 8/2A1F are mentioned contrary to the above mentioned document pertaining to school site plan, building plan regulation under DTCP. The same anomalous scenario reflects in stability & License certificate produced by the management; Hence the anomaly in terms of the three S.F.No.s should be clarified and certificate of land should be obtained by clearly mentioning it for exclusive school purpose in a single contiguous plot of land with exact measurements in S.F.No.s in sync with other documents submitted by the school management for land.
    - Stability should be obtained for the entire circumference of the compound wall 111
    - A small part near stairs has a wide gap and hence it should be closed with grill IV or wall to ensure safety of the students immediately.
  - Compound wall should be constructed along the entire circumference of the school to demarcate the school premises from the adjacent higher education institution.
  - Construction work underway shouldn't be affecting the school functioning and Vi adequate safety should be exercised by segregating and cordoning off the work area from the school functioning part of the building.
  - Zinc sheet roof covering in the entire central square of the building should be VII covered under stability certificate and report regarding the same should be submitted to this office.
  - Copy of Fee details should be displayed in School Notice Board Permanently. VIII
